

Quick Reference Guide (QRG) for the Supply of Rabies Vaccine

Background

- Public Health England (PHE) have advised that a supply of rabies vaccines are kept by acute trusts.
- The Rabies and Immunoglobulin Service (RIgS) at PHE Colindale operates between 8:00am and 5:30pm Monday to Friday and provides advice regarding which patients should receive the vaccine and Immunoglobulin. The contact number for all queries is 0330 128 1020.
- PHE will arrange delivery of rabies vaccine during normal working hours, Monday to Friday.
- Outside of these hours, the Colindale duty doctor service is available (see link below for information regarding when they should be contacted).
- Any NHS rabies vaccine that is used as per PHE guidance/advice for rabies post-exposure treatment will be replaced with stock from PHE free of charge, by contacting the RIgS on 0300-128 1020 with the next working day.
- A supply of rabies vaccines are stocked within the SRFT and NMGH pharmacy departments (the vaccine is stored in a fridge). See below for locations.

 Rabies Immunoglobulin is not stocked at any NCA site. Any requests for this product must be directed to RIgS at PHE Colindale.

Procedure for Vaccine Supply Out of Hours

- Ensure that the assessing clinician has contacted PHE Colindale and they have been advised to administer the vaccine. Do not supply if PHE Colindale have not been contacted.
- If the patient is at SRFT or NMGH, direct the clinician to the relevant location.
- If the patient is at ROH, FGH, RI or the request is from a non-NCA location (such as a GP), contact SRFT pharmacy to arrange a supply.
